Core Workshop Program - These workshops are groups of 3-5 clients with 2-4 staff working four hours at at time each week on projects of the clients' choice. Projects are often miniature model and/or carpentry projects. We also do video and theater projects. Attendance in 2014 increased to over 40 students participating in the program. This program includes one-on-one counseling and therapy as needed. The Core workshop program now includes a Model Employment component where successful participants in the workshop program do work around the premises cleaning and building needed projects while earning minimum wage. We also have a software development component giving students opportunities to learn about the software industry while participating in the development of an iphone app that teaches executive function skills.

2. We are a small organization with 2 full time employees and a handful of part time employees but we received donations from 99 individuals in 2015 ranging from \$20 upwards. Only 6 donations were \$5,000 or more.

3. We are (in 2016) completing arrangements with the Golden Gate Regional Center and California State agencies to begin receiving state and federal government support for our programs. This should move our % of public support to 40%-50% by FY 2017.
